V. Agenda Items

1. ZP#2019-007 Morais Properties, Inc - Aroma II Wine Tasting Room, 14871 Washington Street Ms. Lockhart discusses the landscape plan that was handed out at the dais in response to Mr. Schneider's previous comments. The landscaping includes evergreen shrubs and canopy tree. She states that the town's crepe myrtle will be relocated.

Al Morgan, representative for the applicant, addresses the dais to answer any questions or concerns from the board. Discussion ensues concerning the architectural shingles, painted brick color as well as the trim, roof, sign and door color.

Councilwoman Cavazos moves the Architectural Review Board approve ZP#2019-007, with the current sign proposal that is illustrated as long as it meets the Architectural Review Board guidelines of 1.5 ft. high for the individual letters and that the entire lettering should not exceed 18 sq. ft. total. Also, that the building will have the black trim on the windows, black/metal bronze front French doors, black metal front porch rails, the building will be painted off white, the roof will be black architectural shingles and if the current rear fence is ever taken down by the home owner the property owner's of 14871 Washington Street will be responsible for constructing a new fence and the soldier courses will be desert sand over the arches and cap and that the property owner's adhere to the landscaping plan that was illustrated tonight within the site plan. Commissioner Kharel seconds the motion.
