A Continuation Meeting of the Mayor & Council of the Town of Haymarket, VA, was held this evening in the Board Room, Commencing at 7:30 PM

7. Agenda Items

A. Parking - Town Center Property

Councilwoman Bare recommends that we break out the Town Center parking by tenants' square footage.

B. Town Center Property - Old Post Office

Scope of work has been provided by the structural engineer. He is estimating approximately \$50,000-\$60,000. He is recommending that we plan on 60 days for completion. We would like to advertise a RFQ. He suggests that if we move on this tonight, we could hold a pre-bid conference March 4-5 and have a deadline of March 15-18 we could potentially award the contract at the April meeting. Project could be done by end of May early June. Bare and Tobias will work with Town Clerk.

C. Town Manager Position Duties & Responsibilities

Council discusses the job duties of the Town Manager. Tobias believes we need to figure out the responsibilities of the position prior to a selection of the new Town Manager. He believes the scope of work is more important than choosing a candidate at this point.

Bare has not seen a Town Manager supervising a Police Department in any other jurisdiction in Virginia. Tobias points out that the Purcellville Town Manager has authority of all departments of the Town.

Aitken understands that the police officers would continue to report to the Chief. Tobias explains that this would eliminate the need of a liaison. Aitken asks if there is anything in our charter that would prohibit having the Town Manager supervise or have oversight of the police department?

Harnest does think that the Town Manager should have some oversight over the police department

Tobias suggests that we table the matter of choosing candidates to interview for the Town Manager position until we have adopted a scope of job duties.
