The purpose of tonight's meeting is for the Council to accept the staff changes made to the proposed FY 2014 Budget, since the Council's last meeting and to discuss the Real Estate Tax Rate for 2013, realized in the FY 2014 Budget.

BACKGROUND

The Real Estate Tax rate proposed during the Council's FY 2014 budget work sessions was \$.164/\$100 assessed value. That rate was "no change" from the FY 2013 Budget. However, since there was an increase in assessed values in the Town for 2013, the Town would realize an increase in real estate tax revenue by maintaining the same tax rate. Pursuant to 58.1-3321 of the Virginia Code, when additional tax revenue is realized from increased tax assessments, the Town is required to advertise that increase 30 days prior to a public hearing. That public hearing must only address the real estate tax increase and cannot be held at the same time as the budget public hearing. That deadline has passed and staff is unable to meet the statutory requirements for the proposed increase. In order to timely adopt the FY 2014 Budget staff respectively requests the adoption of the lowered tax rate necessary to offset the increase in Real Estate tax revenue. That rate is \$.153/\$100 assessed value. The budget presented to you this evening reflects the decrease in Real Estate tax revenue from \$311,000 to \$291,032. The difference of \$19,968 has been reduced in the CAPITAL FUND EXPENDITURES - WASHINGTON STREET CASH RESERVES line item.

RECOMMENDATION

It is recommended that the Council adopt the following:

Motion to adopt the lowered real estate tax rate of \$.153/\$100 for the 2013 real estate tax assessments, of which the revenue from will be realized in the FY 2014 Budget.
