Special Meeting of the Planning Commission is called to order

The purpose of the special meeting of the Planning Commission is to discuss an application for a temporary ice rink for Prince William Hockey Club.

Marchant Schneider, Town Planner, gives an overview of the proposed Prince William Hockey Club. Chair Landwehr comments that if this were to go to a permanent use, the site plan requirements that may be waived for the temporary use should be instituted. Mr. Evans would just like the temporary approval now. Chair Landwehr would like this for the record that the waivers are just for the temporary application before us tonight.

Ms. Landwehr moves to schedule a joint public hearing to temporarily waive site plan requirements of 58-259(b) and Article III of the Zoning Ordinance and associated landscaping, buffering, open space, streetscape requirements, and the provisions for temporary trailers as related to the temporary installation and operation of an ice hockey rink at 15151 Washington Street, however, a sketch plan is required. If the applicant wishes to go beyond one (1) season the applicant will come back through the site plan process for a permanent solution, Bare seconds

Ms. Edwards asks about lighting, making sure it is well lit. Applicant responds that there is sufficient lighting already in place. Cole asks about the power source, it is electric. He also asks how late the games run. Answer is midnight-12:30 a.m. He comments that if there is potential for an issue with noise we will have to deal with it. Weir asks if there are any provisions for recreational ice time. No, ice time will be used for the club. Mayor asks where the spectators will sit if the ice rink takes up most of the space.

The provisions of the zoning ordinance considered to be waived include landscaping, buffers and street-scape requirements including the buffering and landscaping as may be required as a condition imposed by Piedmont Tire and Auto site plan. In addition, to consider waiving the ordinance requirement 58-258(15), special use requirement for temporary trailer, and any other zoning ordinance requirements related to this application, Cole seconds;

Annual Contract Maintenance & Repair

The Town Manager is recommending that when we have bid out maintenance and repair work RLS Construction has consistently been the low bidder. They do good work in a timely manner. He got 6 bidders on the project for the 2 tenants upstairs. He recommends that we enter into an annual agreement with RLS to perform maintenance and repair.

Edwards moves that the Town Manger and Town Attorney are authorized to negotiate a contract with RLS Construction for the repair and maintenance of Town owned property for a period of 1 year, Scarbrough seconds;

Mayor is concerned with a 1 year contract; she recommends a caveat of an "out". Any project between \$5-10 anything under \$5K he would have the authority.

Town Center Property Leases

There are three proposed leases for council's consideration. Mr. Kennedy is party to one of the leases and he is out of town and asked if we could defer this matter until he returns. When the Town Manager was hired he was told to negotiate leases, but we have negotiated leases. The two here tonight are current tenants and are moving to accommodate the new larger tenant from Mr. Kennedy. He is happy to bring the leases back to TC as they come up. He is also asking the Council to authorize the TA and TM to negotiate the larger lease with Mr. Kennedy. He is looking for some direction from Council. Edwards remembers having a discussion that the Mayor, Town Manager, and Town Attorney could negotiate leases.

Tobias says he is not a landlord or an attorney. He found one lease in particular that was signed and then modified. Negotiating a lease is one thing executing a lease is another. He compliments the Town Manager on his negotiating but thinks the council reserves the right to spend money.

Weir dovetails with Jay, specifically to the lease with Daytime Playtime, there were multiple requests from the previous tenant some approved, and the latest was not approved. He personally wants to be kept up on lessee that are not keeping up on rents, amendments, new leases, etc...He is not inclined to dispose of that oversight.

Cole doesn't disagree he does want to say that we should not micromanage this task. Have the Town Manager handle it. In fact, he thought that was already delegated.

The Town Attorney thought that was delegated to the Town Manager and time could cause you to lose a tenant. He feels we are moving backwards by having Council input on everything.

Mayor says she was aware of the rent reduction with Daytime Playtime. As far as that particular lease she thought it was better to keep the tenant than to lose them.

Edwards motions that the Town Manager, the Mayor, and with assistance from the Town Attorney have the authority to negotiate leases on the Town Properties with the caveat that if something in the lease drastically changes that they have to report back to council, Scarbrough seconds;

TM talks about moving her, looking at the big picture with the property, its not the change, it's the notification process more than anything else. He's not terribly adverse with delegating that authority but he wants to set a floor and any amendments




