# HAYMARKET TOWN COUNCIL MEETING JULY 15,1985.

Four members of Council made up the quorum at the July 15,1985, Haymar-ket Town Council Meeting, they were; Mr. Crouch, Mrs Freeborn, Mr. Melton and Mr. Utz. It began with a Prayer and Pledge of Allegiance at 8 p.m. Minutes of the June meeting were read and approved. The Treasurer reported a balance of \$15,846.09 in the General Account and \$834.52 in Revenue Sharing at the end of June. A bill for \$110.95 for printing done by Charles C. Necessary was unanimously approved to be paid in a roll call vote.

#### IN OLD BUSINESS:

Mayor Gertrude Bean thanked the Fewell Meltons for taking care of the shades and drapes previously approved for Town Hall.

#### LETTERS READ BY MAYOR:

The Mayor read several letters received from Town Attorney Turner Smith recently. One was in regards to an errors and omissions policy. Mr. Smith suggested checking with the Muncipal League as well as Ratcliffe Ins. Co. about receiving a quote on the price.

Another Letter was read stating that the request made by the Town to use Prince William County's Board of Building Code Appeals would be on the Agenda of the Board of County Supervisors on Aug. 6. This was in regards to a request made by the Town.

### BUSINESS LICENSES RECEIVED:

#jerry and Curtis Simpson received a business license to operate Simpson's Trucking Co. on Orndoff's property, formerally where Blade and Chain were located. The motion to grant it was made by Councilman Crouch, seconded by Councilman Utz and unanimously approved.

#Donald Masuret received a business license to operate a car lot on the Paxton Property. He mentioned that there would probally only be 6 or 7 cars there at one time. The motion to approve this was made by Mr. Utz, seconded by Mr. Crouch and unainimously approved.

#### BUILDING PERMIST GRANTED:

#Century Stair Co. received a building permit for a Metal Storage shed, 80x100, with a concrete floor and roof, no sides. Mr. Crouch made the motion on this, seconded by Mr. Utz and approved.

# Alan Gossom received a building permit for an 8 X 33 ft. Lean-To off the present Hardware Store. It will contain a concrete floor, roof and frame siding. This is to be used for storage. Mr. Crouch made the motion, seconded by Councilwoman Terri Freeborn and approved.

## OTHER ITEMS BEFORE COUNCIL:

# Tom Gillespie from Quarrels Oil Co. came before Council and discusses the work they were doing at Holladay's Market. They are moving a 4,000 gallon deisel tank over to the side away from the Gasoline Pump. He did not have a proper drawing showing where each pipe would be located, etc. Councilwoman Terri Freeborn made a motion that it could be done providing the proper drawings were presented and after John Berger had inspected and approved it, this was seconded by Mr. Melton and approved by Mr. Utz, Mr. Crouch abstained from voting.

# Terry Anderson and another represenative from the office of Walter L. Phillips, Inc. came before Council to discuss the planes of the new First Virginia Bank, this is to be a Colonial Style Building with a drive-in in the rear. No building permit was issued and it was suggested by Council that they check with Richard Bird at the Fire Dept. about their building plans and what they were going to do about the drainage as Council was worried about the Bank's drainage plan.

#Phillip Peach was informed that he could not put a duplex house on LotA at 6600 Jefferson St. as that would be considered two houses and there wouldn't be room enough as 20,000 square feet was needed for each house.

#Terri Freeborn asked about a report from Mr. Smith about the delinquent taxes in Town his office is working on. Mr. Smith informed her he didn't have one at this time.

#Freeborn also mentioned they didn't expect to have a Haymarket Day this year but would put their efforts towards the Gainesville School's 50 Anniversary Celebration.

The Mayor discussed the Trash Contract with ABC Disposal Co. which expires Oct. 31,1985. It was decided that sealed bids will be accepted during th month of August. Mr. Smith will check and let the Council know if this is to be advertized in the newspaper.

With no further business, the meeting adjourned at 9;30 p.m.
